1 EXECUTIVE SUMMARY

The purpose of this document is to provide a map of stakeholders with interest in developing and/or implementing Climate Change adaptation and mitigation strategies in the three European Regions of the LIFE ADAPTA BLUES project: Zeeland, Cantabria and Coimbra.

This map of potential stakeholders will serve as an audience database for knowledge transfer and dissemination of the outputs of the LIFE ADAPTA BLUES project.



2 INTRODUCTION

The stakeholders are all the parties that could be interested in a project and can either affect or be affected by it.

In accordance with the guidelines set out in the *Recommendation of the European Parliament and of the Council concerning implementation of Integrated Coastal Zone Management in Europe*, the stocktaking exercise will group the stakeholders in four categories: 1) managers or institutions with executive powers, 2) academia or research institutions, 3) end-users and business organizations and 4) nongovernment organizations.

The selection of stakeholders has been done taking into account organizations who i) are directly involved in the project, ii) are potential beneficiaries of the project's results, and iii) support the project (directly or indirectly).



3 MANAGERS

Managers are stakeholders with competences over at least one of the next sectors: fisheries and aquaculture, transport, energy, resource management, species and habitat protection, cultural heritage, employment, regional development, tourism and recreation, industry and mining, waste management, agriculture and education.

Due to the political organization of The Netherlands, Spain and Portugal, different bodies, at different levels, are involved in the management of the coastal areas. Those states are divided into regions (which show varying degrees of autonomy) that are also comprised of different municipalities. So, national, regional and local institutions have been considered from each European region.

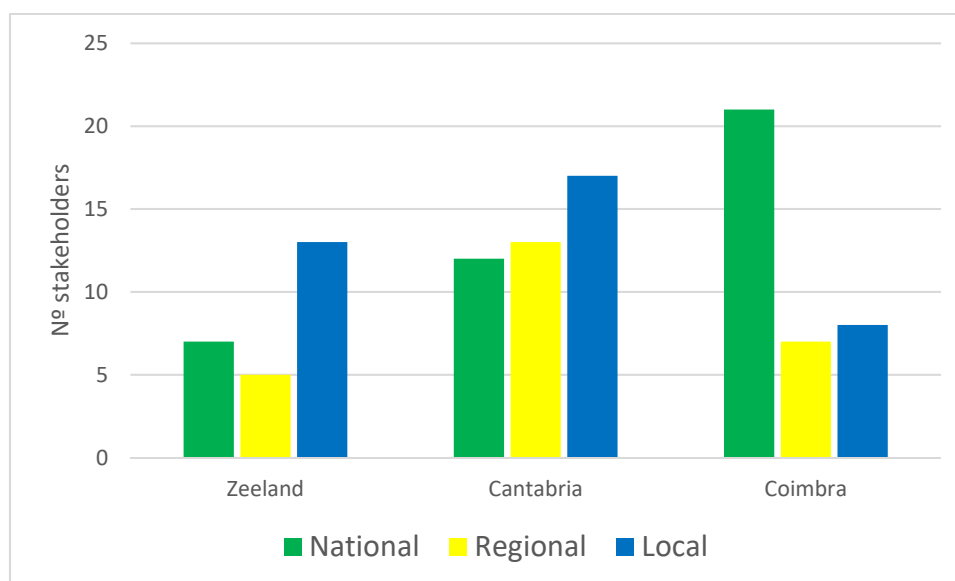


Figure 1. Types of manager stakeholders in the three regions.

42 manager stakeholders have been identified for the region of Cantabria, 36 in the region of Coimbra and 25 in the region of Zeeland (Annex I). Figure 1 shows the number of stakeholders with competences at different spatial scale in the coastal area (from local to national level) identified for each study region. It represents the complex coastal management framework for the three regions, with several managers of different administrative scopes involved.

Zeeland and Cantabria show a greater number of local managers while in Coimbra the national managers of the coastal areas are the most abundant.

4 RESEARCH INSTITUTIONS

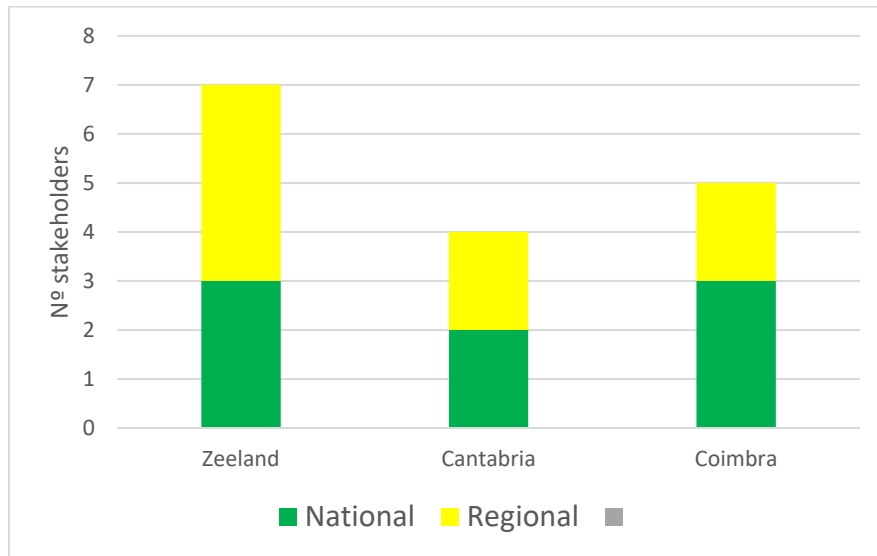


Figure 2. Number of research stakeholders identified in the three regions.

The first aspect to note concerning the research stakeholders is the low number of stakeholders identified in the three study regions (Figure 2). Nevertheless, the database generated (see Annex 1) should be considered as a the starting point to identify the main stakeholders to engage in

the project, so to which all the different partners of the project as well as stakeholders involved can contribute by proposing additional actors.

No local research institutions have been taken into account for this stakeholder's stocktaking.

5 END-USERS AND BUSINESS ORGANIZATIONS

In the case of companies and end-users, the stakeholders have been grouped by sectors: primary (those companies dedicated to extraction of raw materials, e.g. fishing), secondary (the manufacturing sector) and tertiary (those companies dedicated to provide good and services to consumers).

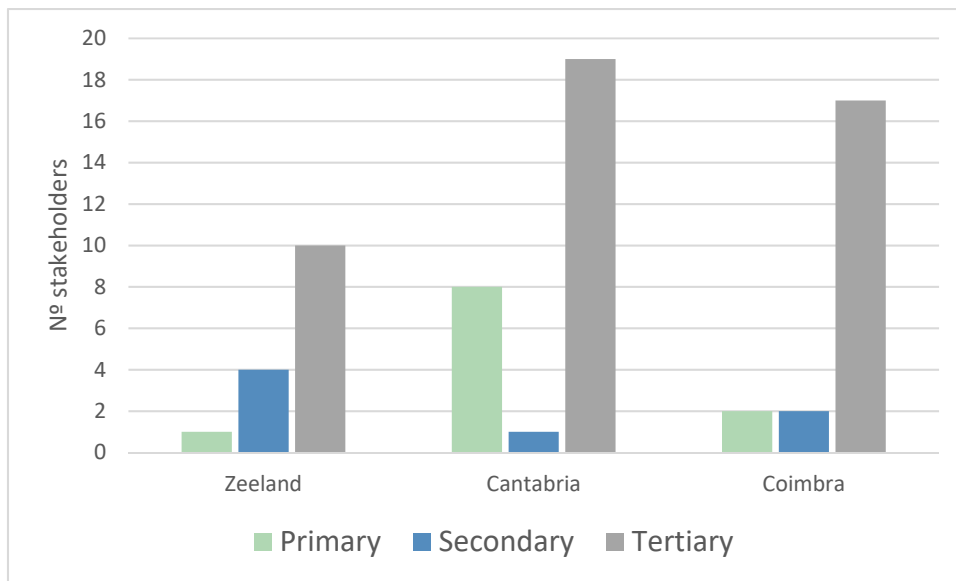


Figure 3. Distribution of end-users by sector in each region.

The first aspect to note concerning end-users is the dominant position of the tertiary sector in the three study regions (Figure 3) due to the inclusion of the **insurance sector** as one of the main stakeholder in this project. On the other hand, Zeeland shows the largest number of end-users of the secondary sector while Cantabria has the biggest number of stakeholders related to the primary sector.

6 NON-GOVERNMENTAL ORGANIZATIONS

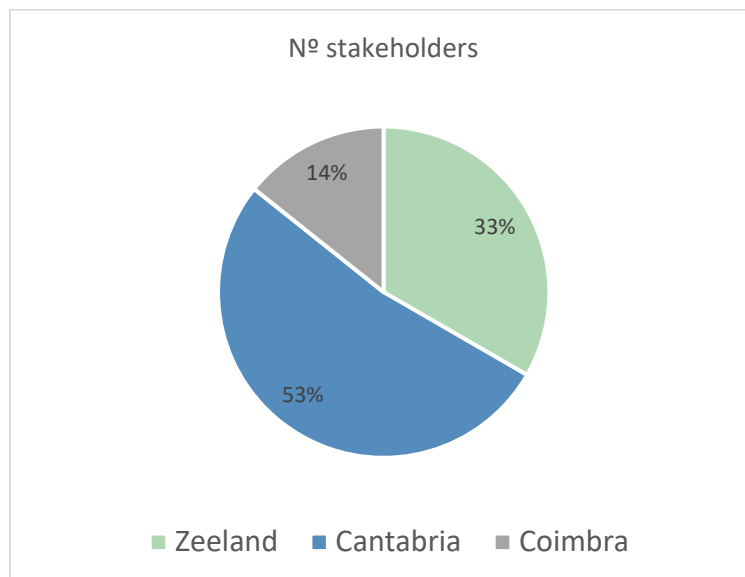


Figure 4. Distribution of NGOs by regions.

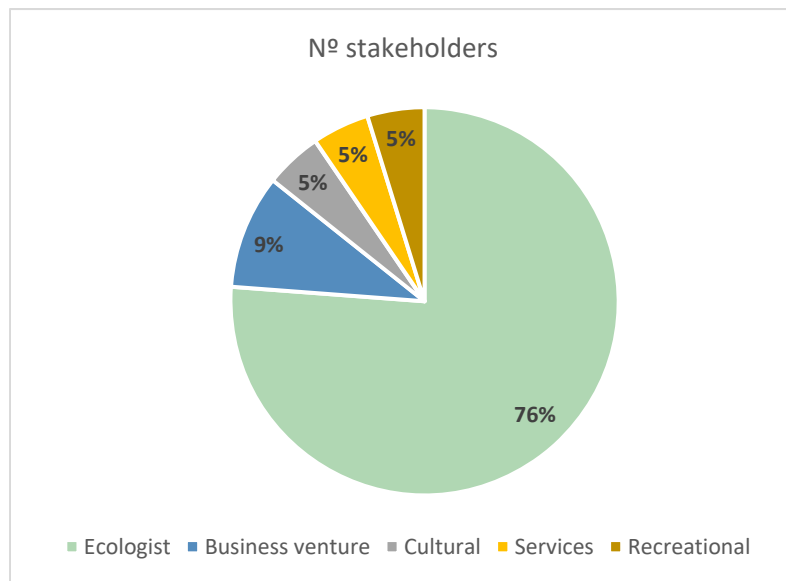


Figure 5. Distribution of NGOs by activity.

The majority of the NGO's identified work in the field of nature protection or have this as their stated purpose. Most of them are ecologist or nature conservationists' groups, although their activities include recreational services, business venture, cultural heritage and other services (e.g. health support). The following chart (Figure 4) shows the number of NGOs in each region as a percentage of the overall number and Figure 5 shows the distribution of NGOs by activity.
